The **CPS** is the Certified Process Server designation. This certification demonstrates that the recipient passed a difficult written exam on the laws and procedures necessary to possess a solid foundation of knowledge for serving general civil process.

The **CES** is the Certified Eviction Specialist designation. This certification demonstrates that the recipient passed a difficult written exam on the laws and procedures necessary to serve general

civil process and orders of eviction. The CES is designed for those court officers and deputies who serve evictions and do not do other types of property seizures.

The **CCO** is the Certified Court Officer designation. This certification demonstrates that the recipient passed a very difficult written 100+ question exam on the laws and procedures necessary to serve general civil process, orders of eviction, and the seizure of personal and real property.
